March 8, 2021

The Sheridan Community Schools Board of School Trustees met for a Regular Board Meeting on Monday, March 8, 2021 at 6:30 p.m. in the Sheridan High School Media Center with board members Todd Roberts, Steve Dollahan, Nancy Boone, John Hunt present, along with Superintendent Mary Roberson.

Quorum Determination – President Roberts confirmed that a quorum was established.
