MINUTES

Regular Meeting of the Sheridan Community Schools
Board of School Trustees
April 19, 2021

The Sheridan Community Schools Board of School Trustees met for a Regular Board Meeting on Monday, April 19, 2021 at 6:30 PM in the Sheridan High School Media Center with board members Todd Roberts, Steve Dollahan, Nancy Boone, John Hunt, and Dan Fleming present, along with Superintendent Mary Roberson.

Quorum Determination – President Roberts confirmed that a quorum was established.

Call to Order/Pledge – President Roberts called the meeting to order at 6:35 and led the group in the Pledge of Allegiance.

Sheridan Showcase – Kris Lingenfelter and elementary SOAR students shared “Spheros in Action.” Students Kelsie Hagan, Grayon Stultz, and Patrick Kelly explained how their project that included a cardboard maze they had created and then how they had programmed the Sphero robot with block coding to navigate the maze.

Consent Agenda - A motion to approve the Consent Agenda as presented was made by Steve Dollahan and seconded by John Hunt. The motion carried 5-0.

- Approved change in Jim Kinsey’s teaching status for 2021-2022 school year to part-time

Salt Barn Update – Roberson shared that the salt barn project is currently on hold because the town has found another option for now.

Accept Donations – John Hunt moved to accept donations as presented. Dan Fleming seconded the motion that carried 5-0.

Contract with Sheridan Youth Assistance Program for Mentoring Grant – Steve Dollahan moved to approve a contract with SYAP for assistance with the mentoring grant. John Hunt seconded the motion that carried 5-0.

Contract with Bowen Center- Steve Dollahan made the motion that was seconded by Nancy Boone to approve a contract with Bowen Center to allow the use of SCS facilities to see patients. The motion carried 5-0.

Approve 2022 Music Department Trip to Orlando, Florida – John Hunt made the motion to approve the 2022 music department trip to Orlando, pending any pandemic related issues. Steve Dollahan seconded the motion that carried 5-0.

Information/Reports, Mary Roberson

- Roberson shared the latest Dashboard, which is very positive.
- Roberson shared the potential for federal grants through CARES and ARPA.

Reopening Plan Review and Opportunity for Public Comment – Roberson shared that the Reopening Plan that was reviewed in the fall needed formal approval and an opportunity for public comment. The plan was shared with the board in August and was shared again. It has been posted on the SCS website since August. An opportunity for public comment was allowed. With no comments, John Hunt made the motion to approve the plan. Dan Fleming seconded the motion that carried 5-0.

Board Member Comments

Nancy Boone commented that she was delighted to have students share at the board meeting. She commended the reopening plan and commented how we have adapted with a “moving target.”

Steve Dollahan commented that we are in the homestretch and to share with the teachers that the board appreciates them.

John Hunt congratulated the winter sports teams – both on their seasons and also the fact that they were able to have a season. In particular he highlighted the 8th grade boys basketball team that was undefeated.

Dan Fleming shared that he was glad to be back! He appreciated the student presentation, commenting that students were engaged and seemed to have fun presenting.

President Roberts thanked Ms. Lingenfelter and students for the presentation. He also thanked the staff for the implementation of the reopening plan.
